Cured with 1.5% NL49P + 1% Butanox M-50. Postcured 24 hrs RT followed by 24 hrs 70°C.

Remarks on curing agents

Butanox M-50 is an AKZO Nobel product, methyl ethyl ketone peroxide (MEKP).

Guidelines before use

Before use, the resin should be conditioned at a well defined, application dependant temperature (usually 15°C minimum for a MEKP / Co cure).

Storage guidelines

The resin should be stored indoors in the original, unopened and undamaged packaging, in a dry place at temperatures between 5°C and 25°C.
